Instructions to the allocated students for Online Reporting to the Institute 25th-30th November 2020

WELCOME TO ALL THE STUDENTS ALLOTTED (THROUGH JoSAA/CSAB-2020) TO NIT ANDHRA PRADESH

All the candidates allotted to NIT Andhra Pradesh are required to report through ONLINE MODE during 25th (Wednesday) to 30th (Monday) November, 2020.

- 1. All the candidates (a) who have secured seat in the sixth round of JoSAA (who didn't participate in CSAB special rounds) or (b) will secure seat in the second round of CSAB (who participated in the CSAB special rounds) MUST report to the NIT Andhra Pradesh through the **ONLINE MODE** during 25th-30th November, 2020 to complete the provisional Admissions Process. During this process, the remaining fee has to be paid (if applicable) according to the details of the fee given below and should fill the online registration form (which will be made available on the Institute website www.nitandhra.ac.in) during 25th-30th November, 2020.
- 2. The candidates need to pay the following balance Institute fee (after adjusting the seat acceptance fee and Partial Admission Fee through JoSAA/CSAB) during 25th-30th November, 2020.
 - a. Balance Institute Fee (General/OBC candidates) Rs. 17,000/-
 - b. Balance Institute Fee (SC, ST, PWD candidates) -Nil-

The candidates need to pay the hostel fee at the time of Physical reporting. Complete fee structure for B.Tech. program is available on the Institute website.

3. **Institute fee has to be paid only through "State Bank of India i-collect".** The fee can be paid online (Net banking) or offline at any SBI branch through the downloaded challan. The downloaded copy of the payment receipt / challan should be kept for all future purposes.
