## INSTRUCTIONS TO THE II, III & IV B. TECH. STUDENTS ODD SEMESTER REGISTRATION A.Y. 2021-22 -DURING 4<sup>th</sup> -6<sup>th</sup> AUG, 2021

- Fee Structure for the students admitted during A.Y. 2017-18, 2018-19, 2019-20 and 2020-21 are available on the Institute website.
- Total Institute fee must be paid by the Open & OBC category students is Rs.68,300/- (Tuition fee of Rs.62,500/- and other fees of Rs.5,800/-) only.
- SC/ST/PWD students need to pay only other fees of Rs.5,800/-.
- MEB students (whose total family income is less than Rs.1,00,000/- per annum) need to pay other fees of Rs.5,800/- only and have to submit income certificate (for the financial year 2020-21 issued on or after 01-04-2021) and declaration from parent (Undertaking form is available on the Institute website.)
- OEB students (whose total family income is more than Rs.1,00,000/- but less than Rs.5,00,000/- per annum) **need to pay total Rs. 26,633/-** (tuition fee of Rs.20,833/- and other fees of Rs. 5,800/-) and have to submit income certificate (for the financial year 2020-21 issued on or after **01-04-2021**) and declaration from parent (Undertaking form is available on the Institute website.)
- If the income certificate issued before 1<sup>st</sup> April 2021 and validity of certificate is for one year then students have to submit latest income certificate for the financial year 2020-21. The **Aadhar number of the parent** is to be mandatorily mentioned on the income certificate. <u>In case the format of the certificate of a particular state does not include Aadhar number, an undertaking on a Rs.50/- non-judicial stamp endorsed with Notary is to be submitted by the <u>student.</u> (non-judicial format is available on the Institute website.)</u>
- If it is valid for more than one year then students are requested to submit the photo copy of the income certificate. If Aadhar number of the parents are not mentioned in the income certificate then students have to submit an undertaking on a Rs.50/- non-judicial stamp endorsed with Notary is to be submitted by the student. (non-judicial format is available on the Institute website.)
- The applications submitted without any of the above documents or in improper format will not be considered for fee remission.

- The applications received after the due date will not be considered.
- Originals copies of all the required uploaded documents are to be submitted in person whenever Institution will reopen for the physical classes.
- Institute fee has to be paid through State Bank of India i-collect only.
- In case of e-challan, payment can be made at any branch of SBI.

- Students having dues of Institute fee will not be permitted to register.

- Late registration dates are from 07-08-2021 to 13-08-2021. Late fee of Rs. 1000/- along with the Institute fee should be paid as late registration fee. (Applicable for all categories i.e., OPEN, OBC, SC, ST, PWD, MEB and OEB)
