Sub: Fee remission for I B.Tech. (A.Y.2020-21) students – Reg.

The B.Tech. first year students who have taken admission in the A.Y. 2020-21 through JoSAA/CSAB are requested to submit the applications for claiming the tuition fee remission based on their parent's income. As per the Government rules the UNRESERVED/OBC students are eligible to get the benefits of fee remission if the family income is as mentioned below.

- i) Most economically backward students (whose family income is less than Rs. 1 lakh per annum).
- ii) Other economically backward students (whose family income is between Rs 1 lakh to 5 lakhs per annum).

The applications are required to be submitted through the google form link:

on or before 22nd January, 2021 with the following documents obtained from appropriate authorities based on the state to which they belong to.

- (a) The Income Certificate issued on the Name of Parent and (b) undertaking for the tuition fee remission (format attached herewith and required to be printed on plain A4 paper) has to be submitted for claiming the tuition fee remission. The Income Certificate issued in the name of the student is not valid. The date of issue of the certificate has to be on or after 01-04-2020.
- 2. The **Aadhar number of the parent** is to be mandatorily mentioned on the income certificate. Certificates without Aadhar number are not valid. <u>In case the format of the certificate of a particular state does not include Aadhar number, an undertaking on a Rs.50/- non-judicial stamp endorsed with Notary is to be submitted by the student. The format for the undertaking is enclosed.</u>
- 3. The income certificate submitted by the students without Aadhar Number will not be considered for fee remission even with the affidavit, if the state provides Income certificates with Aadhar Number. Hence, no further communication in this aspect will be entertained.
- 4. The **issuing authority** of the income certificate shall be according to the enclosed list for each state of the country. Certificate issued by any other authority is not valid.

- 5. The applications submitted without any of the above documents or in improper format will not be considered for fee remission.
- 6. The applications received after the due date will not be considered.
- 7. Originals corresponding to the uploaded documents are to be submitted in person whenever institution opens.
- 8. All students are requested to take utmost care while uploading the documents (pdf copy only) through google form.
- 9. The final list of eligible candidates will be published on Institute website before the registration to the next semester. The students have to pay the tuition fee accordingly at the time of registration.
