ODD SEMESTER REGISTRATION A.Y. (2022-23) -DURING 8th -13th Aug. 2022

All the B. Tech. II, III, IV Year students must be physically present and submit the below-mentioned documents to the admissions office (**Room No:010**, **Ground Floor**, **SV PATEL Central Vista**) during 08th Aug -13th Aug 2022 to complete the semester registration process.

- (a) Hard copy of the fee payment receipts,
- **(b)** Filled and signed copy of the registration form,
- (c) Relevant documents to get fee remission (applicable for the OEB and MEB category students)

Documents required to be submitted by the OEB/MEB category students

- (i) Application form for fee remission (prescribed format is attached herewith in Annexure-A),
- (ii) Declaration in the non-judicial stamp paper for fee remission (prescribed format is attached herewith in Annexure-B).
- (iii) Family income certificate in the name of father [or mother (in absence of father)]/ guardian (in absence of parents) issued by the competent authority (as prescribed by the respective the State Governments) after 1st April 2022 (irrespective of the validity of the certificates submitted by the candidates in previous year/ semester) for the financial year 2021-22 (i.e. from 1st April 2021 to 31st March 2022).

Note:

- 1. If the "Family income" phrase is not mentioned in the income certificate, then individual income certificates in the name of both father and mother are must be submitted.
- 2. Death certificate/ certificates along with declaration by the student in the prescribed format (prescribed format is attached in Annexure-C) are required to be submitted if father/ mother/ both the parents are not alive.
- 3. All the II, III, IV B. Tech. (OPEN, OBC, EWS) students, who are interested to freshly apply for fee remission, must pay full fees along-with the application form for fee remission and relevant documents. If found eligible, after scrutiny, the balance amount will be refunded to the candidates.
